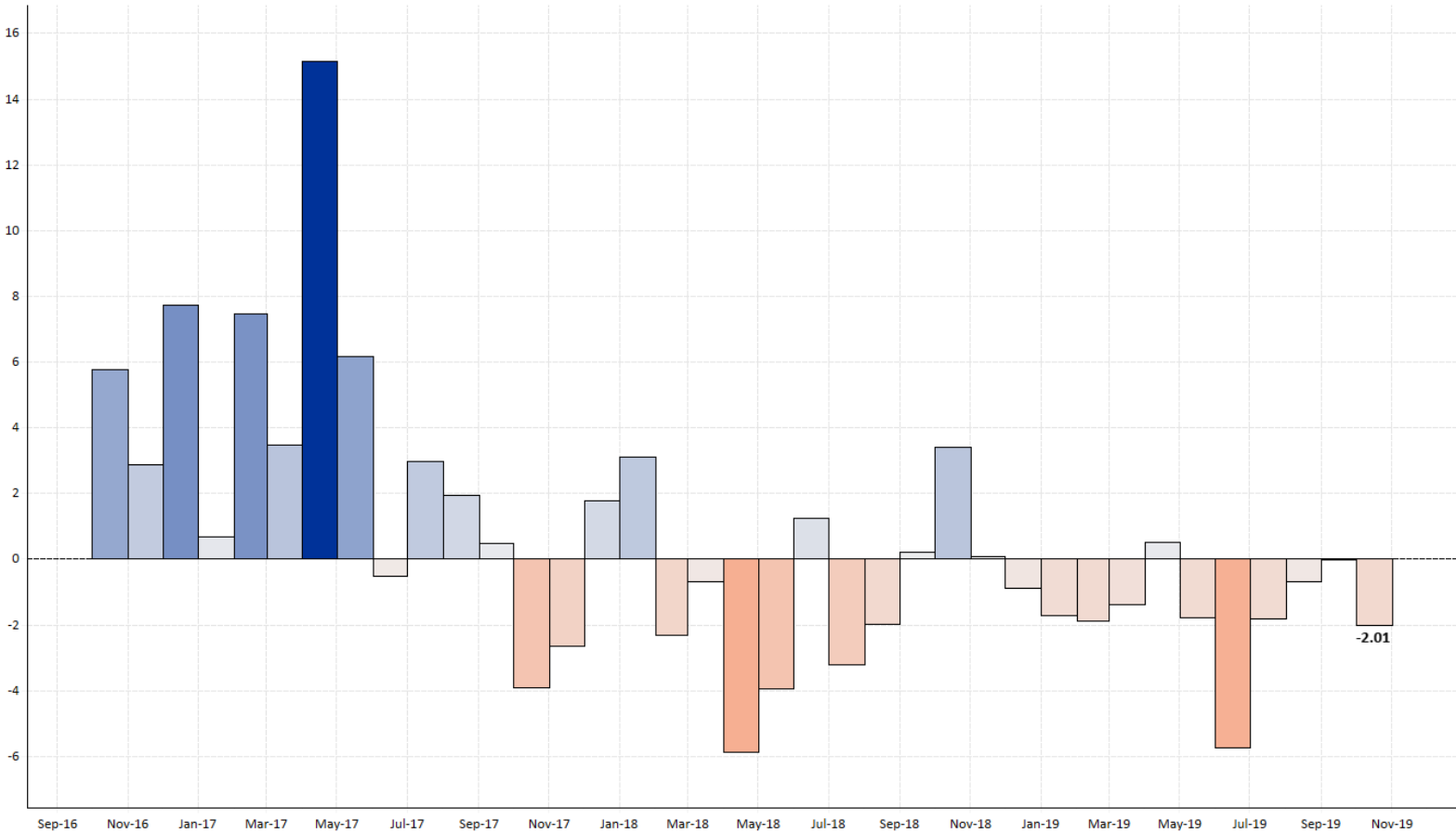

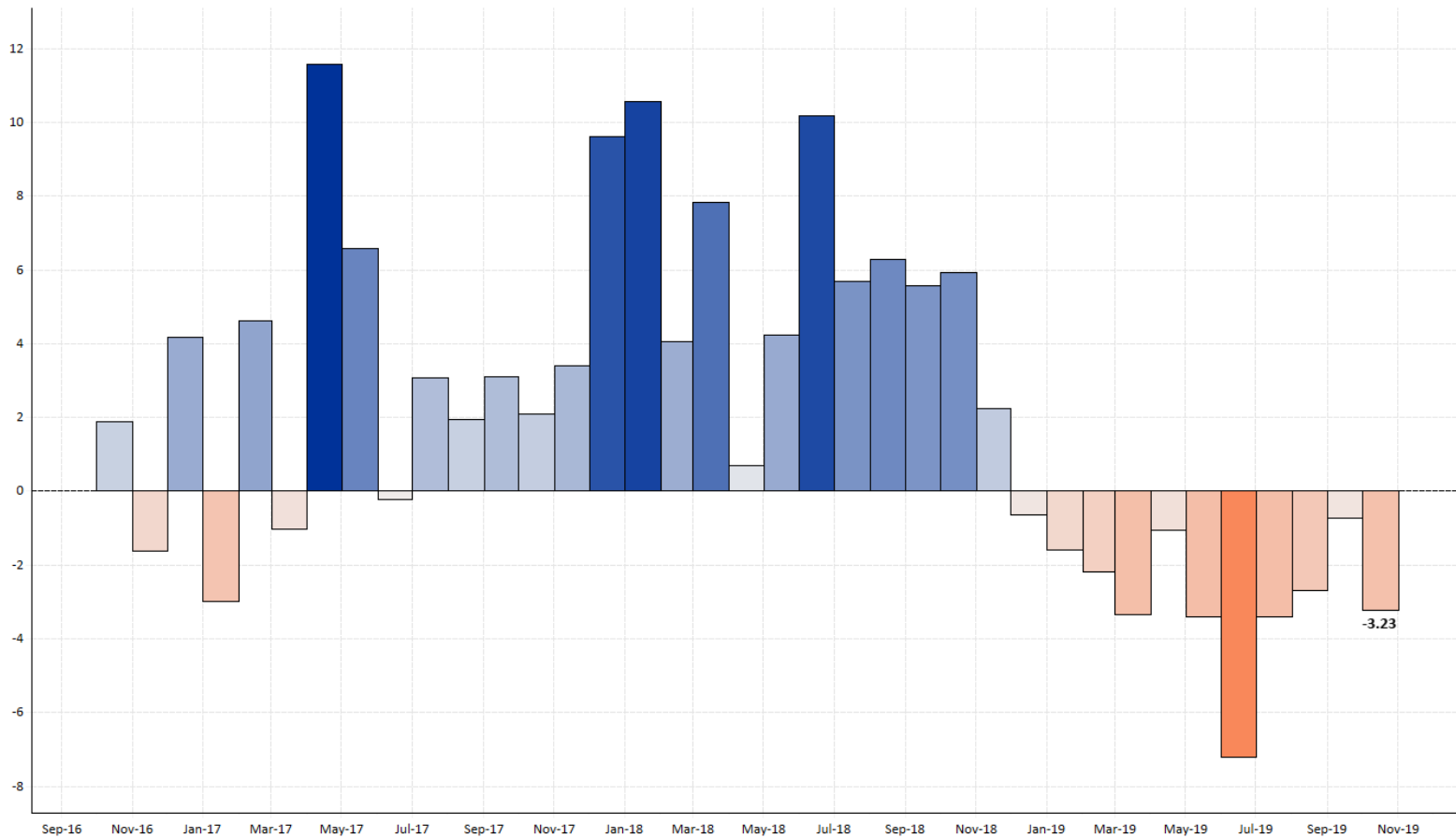
## yearly growth rate, % (daily average volume per month)

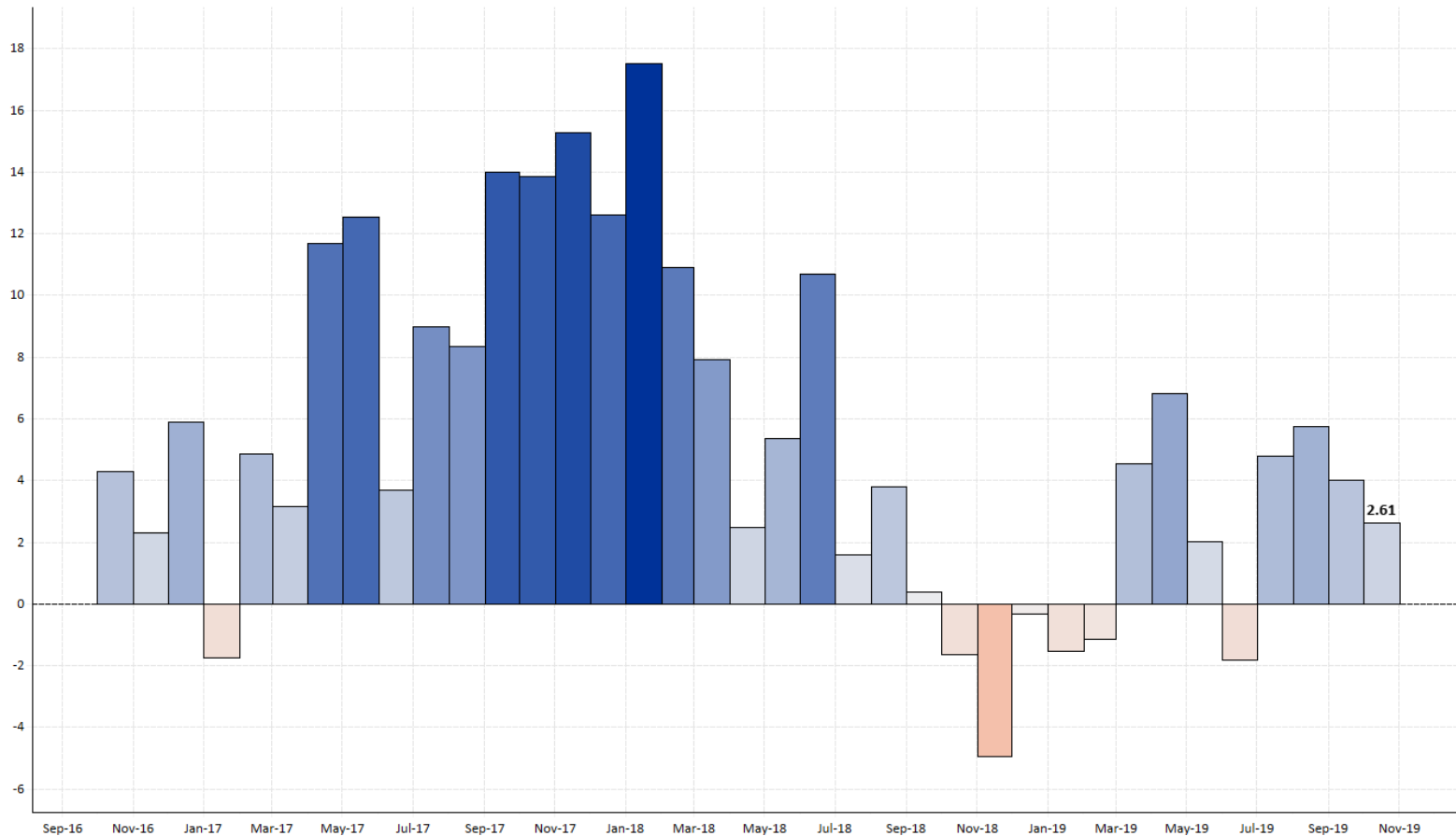
## yearly growth rate, % (daily average volume per month)

# Interbank Payments, Oct 2016 – Oct 2019

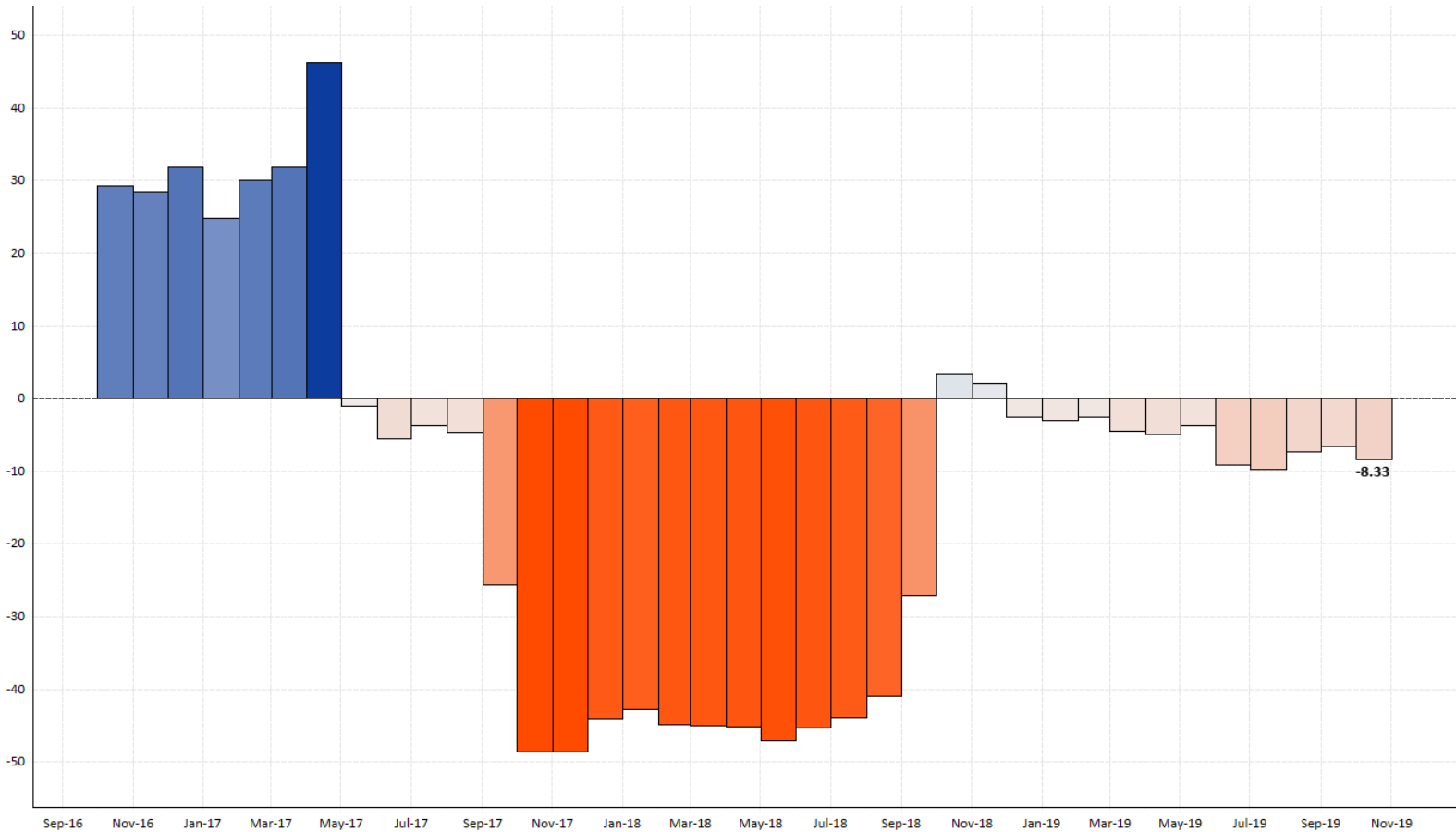

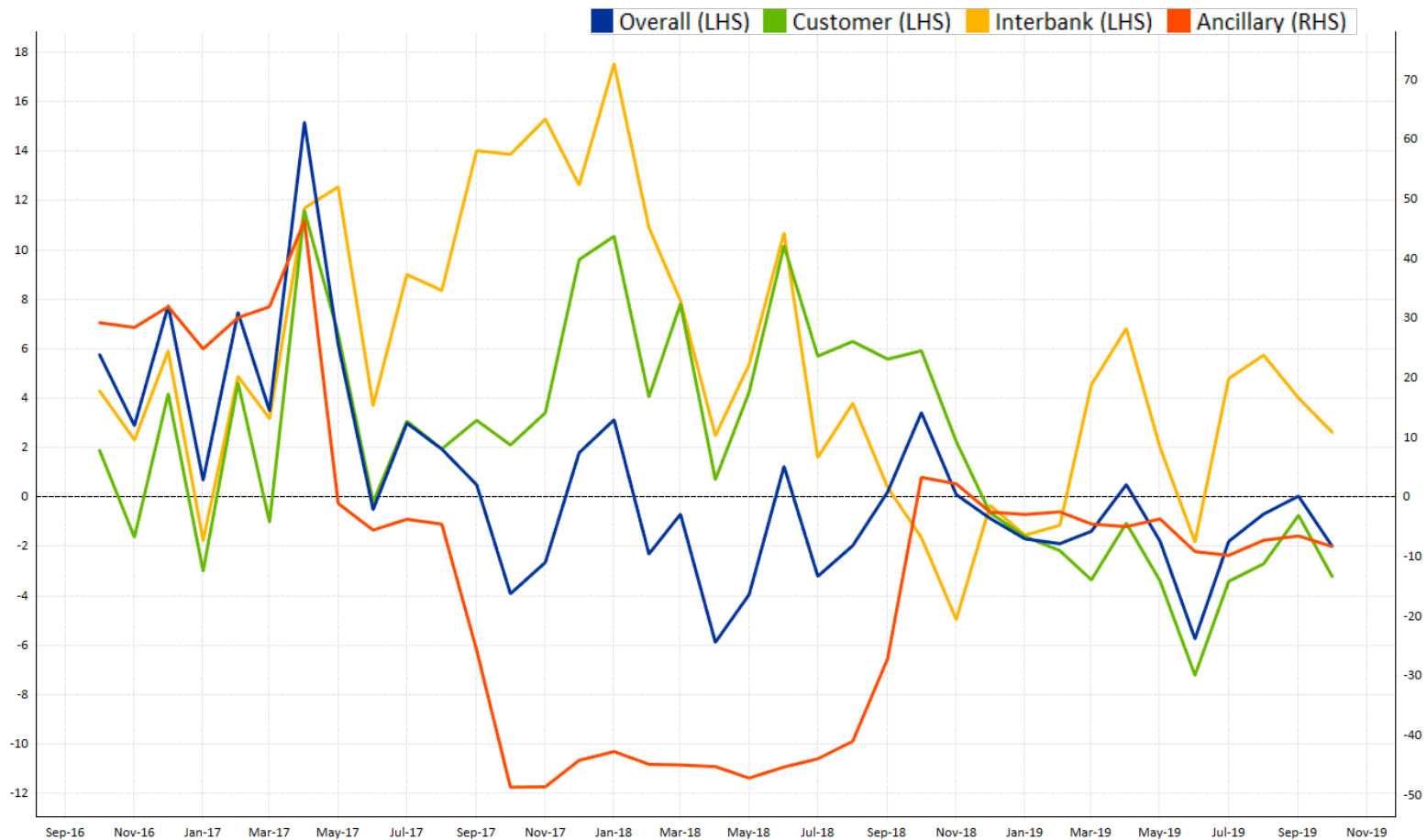

# Volume developments trends, Oct 2016 – Oct 2019

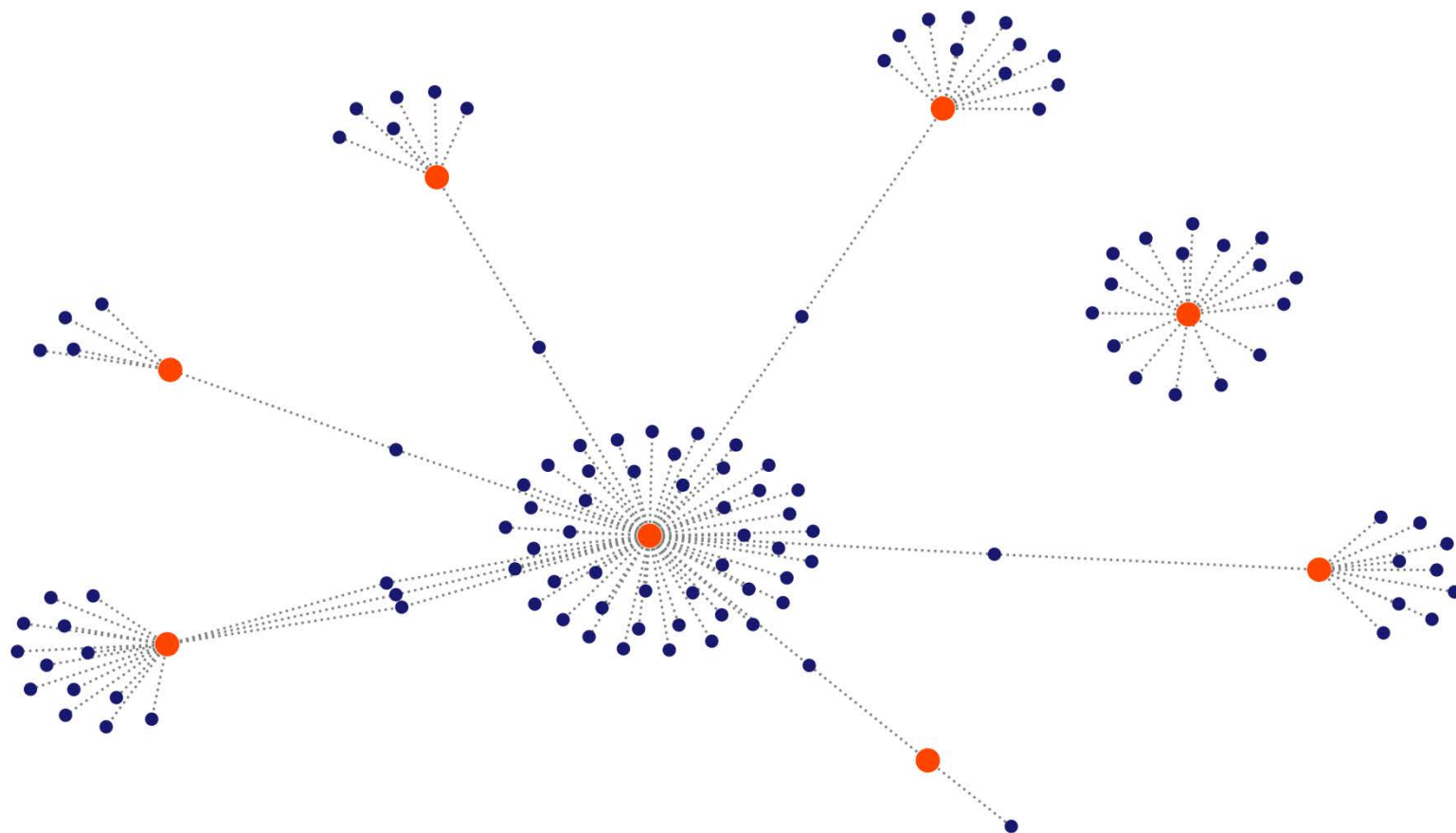

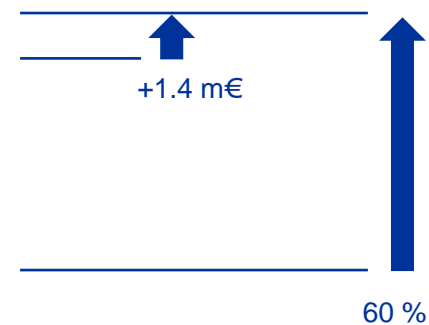
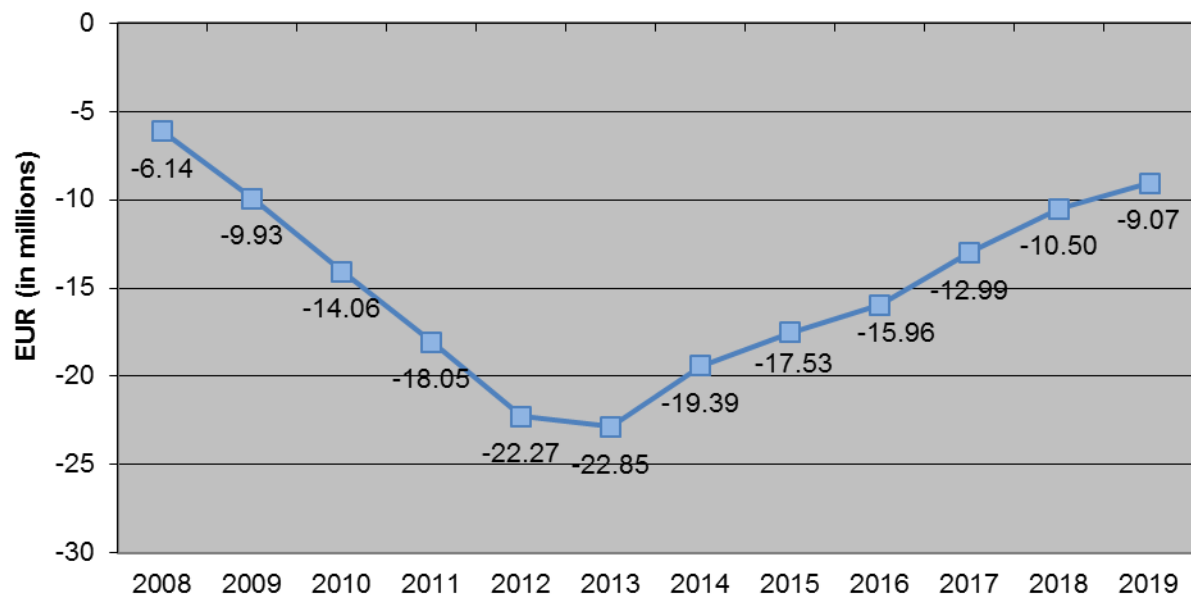

2019 – 2020	End-point security	<ul style="list-style-type: none"><li>• Revised self-certification arrangement for TARGET2 participants</li><li>• Endpoint Security Compliance Implementation Framework</li><li>• Compliance with the SWIFT Customer Security Programme (CSP)</li></ul>
Nov 2020	TARGET2 release 14.0	<ul style="list-style-type: none"><li>• Only potential mandatory changes to the system (no changes currently foreseen)</li></ul>
Nov 2021	End of TARGET2's lifespan	<ul style="list-style-type: none"><li>• Go-live of T2-T2S consolidation project</li></ul>
